APPLICATION


Temperature.....	40°F to 110°F
Method.....	Brush, roller, standard spray
Preparation.....	Surface must be dry, dirt, oil and grease free.
Coverage.....	Up to 530 sq. ft. / gal depending on application
Clean-Up Wet.....	Soap and water
Clean-Up Dry.....	Solvent (use safe-handling practices.)
